Dear Assembly Member/Senator,

Re: Faith Leaders' Support for SCAR Act & Drivers Licenses for All

As leaders of religiously diverse congregations as well as faith-based and other organizations across the State of New York who welcome immigrant New Yorkers to our communities, we are writing to urge passage of two NYS bills of critical importance to the lives of thousands of immigrants throughout New York State:

Driver's Licenses for All – A. 10273 (Crespo) and S. 0868 (Sepulveda) - that would allow access to driver's licenses for all qualified drivers, regardless of immigrant status allowing those who live in transit deserts and rural parts of New York State access to supermarkets, doctor appointments, schools and other basic services.; and

Separation of Children Accountability Response Act – the SCAR Act – A. 1436 (Epstein) and S.222 (Benjamin) that would require immigrant holding centers throughout the state to provide information to the State Legislature about the condition of youth being held, so advocates and policy makers will have the information they need to ensure that their needs are being met.

The Trump Administration's punishing efforts to marginalize undocumented immigrants intensifies the urgency of passing these bills in 2019 – bills that ensure that many whose livelihoods and the well-being of their families depend on it can obtain driver's licenses, and that young immigrants who have been separated from their families by force inside our country--and those who came across the border unaccompanied-- are nurtured and protected.

Over the decades, New Yorkers have heeded the words on the Statue of Liberty to open our "Golden Door" to immigrants and benefited in immeasurable ways from their contributions. Not only are we called by our respective faith traditions to welcome the stranger, but our Constitution promises basic

rights for all those on US soil--citizens or not. We are calling on our elected representatives to support two bills that are essential to protecting immigrants' rights and our collective future.

We plan to follow up shortly to learn about your position on these bills and answer any questions you might have.
